This agreement witnesses that the Customer and BC Hydro agree as follows:

1. The total electrical demand for the premises shall be measured or otherwise determined by BC Hydro separately from any secondary metered accounts.
2. A monthly/bi-monthly transformer ownership discount as set out in Rate Schedule \_\_\_\_\_ of the BC Hydro Electric Tariff shall be provided to the Customer and shall be in the form of either:
  - (a) a monthly/bi-monthly credit to the Customer’s account with BC Hydro.
  - (b) a cheque payable to the Customer where the Customer does not have an account with BC Hydro.

Should there be a change in registered ownership of the property and distribution transformer(s), then BC Hydro is to be notified by the Customer immediately. If the Customer is to continue receiving the transformer ownership discount after such change in registered ownership, then a letter from the new Property Owner (on company letterhead) authorizing BC Hydro to provide the transformer ownership discount to the Customer, must be provided to BC Hydro. If the new Property Owner or the Customer has a GST/HST registration number, please ensure the GST/HST registration number is noted in the authorization letter and indicate to which party (owner/supplier or customer) the GST/HST registration number belongs.
